BODYBUILDERS & PHYSIQUE POSING ATTIRE:

Posing suits must be worn and be of solid color, opaque, devoid of embroidery, stripes or other embellishments. Accessories are not permitted including jewelry. At Finals, accessories & props attached to body may be used.

FIGURE POSING ATTIRE:

Two piece swimsuits and heels. No thongs may be worn in either round. Embroidery or embellishments are allowed on suits.

BIKINI POSING ATTIRE:

Two-piece swimsuits and heels. No thongs may be worn in either round. Embroidery or embellishments are allowed on suits

50% coverage, Photo must be sent to confirm eligibility

CLASSIC SWIMWEAR 1 & 2 PC POSING ATTIRE:

One or Two-piece swimsuits and NO shoes. No thongs may be worn in either round. Embroidery or embellishments are not on suits

50% coverage, Photo must be sent to confirm eligibility

MALE PHYSIQUE ATTIRE:

Wear board shorts, just above knee in length & 1' below the belly button. No spandex or logos are permitted on shorts, however a manufacturer's logo such as Nike or Billabongs are acceptable. No foot wear, No body accessories

POSING MUSIC: Bodybuilders will pose to music of their choice at night

finals only. If you are entered in more than one class, you will pose only once. Music will be limited to 60 seconds. Music must be cued to start and recording must be of good quality. Music should be EMAILED to RAYFLEXADKISON@GMAIL.COM in MP3 or MP4 format only.
